### A tribute to Harriet Rotter...

The Commission was immensely saddened to learn of the passing of long-time Commission Member Harriet Rotter on December 23, 2022.

Harriet was appointed to the Commission in 2003. During her tenure she supported and led numerous projects including several large initiatives such as restoring a large Jewish cemetery in Vilnius, Lithuania and the installation of a Holocaust memorial in Bryansk with the Russian Jewish Congress.

Her fellow Commission Members remember her for her kindness and dedication to the work of the Commission. In addition to her commitment to the Commission, Harriet was a volunteer and public servant for most of her life. Harriet served on the board of Central Michigan University from 1993-2000 and the board of the John F. Kennedy Center for the Performing Arts from 2002-2008.




She was well-known as one of the most sought out family law attorneys in the metropolitan Detroit area.

Harriet died at the age of 83, less than a year following the death of her beloved husband of 63 years, Dr. Norman Rotter.
